GRANT OF A LICENSE FOR ELECTRIC VEHICLE CHARGERS FOR JUMPSMARTMAUI (HAIKU; KIHEI; LAHAINA; WAILUKU) (EAR-25)

DESCRIPTION: The Committee is in receipt of County Communication 14-292, from the Director of Office of Economic Development, transmitting a proposed resolution entitled "AUTHORIZING A GRANT OF A LICENSE OF COUNTY REAL PROPERTY FOR THE INSTALLATION, OPERATION, AND MAINTENANCE OF ELECTRIC VEHICLE QUICK CHARGERS AND LOCAL BATTERY UNITS". The purpose of the proposed resolution is to authorize a grant of a license of County real property to Hitachi Advanced Clean Energy Corporation, in association with JUMPSmartMaui, for the installation, operation, and maintenance of electric vehicle quick chargers and local battery units at Haiku Community Center, Kihei Community Center, Lahaina Aquatic Center, and the Kalana Pakui Building (Wailuku Civic Center).
