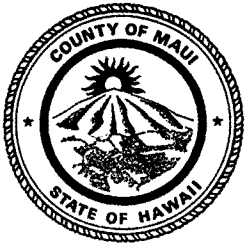

LITIGATION MATTERS (STATUS: ROBERT ITO FARM, INC., ET AL. V. COUNTY OF MAUI, CIVIL 1:14-CV-511; and ALIKA ATAY, ET AL. V. COUNTY OF MAUI, ET AL., CIVIL 14-1-0638(2)) (COW-1(1))

DESCRIPTION:

The Committee is in receipt of the following:

1. Correspondence dated January 2, 2015, from the Department of the Corporation Counsel, requesting an opportunity to provide a status update on the cases and transmitting copies of the Complaints. The cases relate to the proposed ordinance entitled "A BILL PLACING A MORATORIUM ON THE CULTIVATION OF GENETICALLY ENGINEERED ORGANISMS" ("the Ordinance"), which was proposed by initiative petition and passed by electorate at the General Election on November 4, 2014. The Complaint in Robert Ito Farm, Inc., et al. vs. County of Maui, Civil 1:14-CV-511, seeks a judicial declaration that the Ordinance is invalid under County, State, and Federal law. The First Amended Complaint in Alika Atay, et al. vs. County of Maui, et al., Civil 14-1-0638(2), seeks a judicial declaration that the Ordinance is valid, enforceable, and should be implemented.
2. Correspondence dated January 20, 2015, from the Department of the Corporation Counsel, responding to questions regarding the County's representation in the cases.

STATUS:

The Committee may discuss the status of the case. The Committee may also consider other related action.
