I. HEARINGS BEFORE THE BOARD:

A. COMPLAINT AND ACCUSATION NO. 2015-11, PLEA: NO CONTEST

In the matter of the accusation against AMBROSIA LLC dba AMBROSIA MARTINI LOUNGE, Dispenser General License No. 331, 1913-H South Kihei Road, Kihei, Maui, Hawaii.

Count 1. On March 1, 2013 and March 2, 2013 between the approximate times of 10:10 p.m. and 12:00 midnight, AMBROSIA LLC dba AMBROSIA MARTINI LOUNGE, a dispenser general licensee, did, through its employee(s), sell, serve, or furnish liquor to, or allow the consumption of liquor by a patron, who was at the time under the influence of liquor, as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, contrary to Section 281-78(b)(1)(B) of the Hawaii Revised Statutes and Section 08-101-60(b)(1)(B) of the Rules of the Liquor Commission, County of Maui.

B. COMPLAINT AND ACCUSATION NO. 2015-14, PLEA: NO CONTEST

In the matter of the accusation against PUPU LOUNGE SEAFOOD & GRILL, LLC dba PUPU LOUNGE SEAFOOD & GRILL, Restaurant General License No. 396, 1945 South Kihei Road, Units C & D, Kihei, Maui, Hawaii.

Count 1. On July 20, 2013 at approximately 9:28 p.m., PUPU LOUNGE SEAFOOD & GRILL, LLC dba PUPU LOUNGE SEAFOOD & GRILL, a restaurant general licensee, did, through its employee, sell, serve, or furnish liquor to a minor, as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, contrary to Section 281-78(b)(1)(A) of the Hawaii Revised Statutes and Section 08-101-60(b)(1)(A) of the Rules of the Liquor Commission, County of Maui.

C. COMPLAINT AND ACCUSATION NO. 2015-16, PLEA: NO CONTEST

In the matter of the accusation against O & Y, INC. dba SANDY'S LOUNGE, Dispenser General License No. 362, 270 Waiehu Beach Road, #105, Wailuku, Maui, Hawaii.

Count 1. On April 4, 2013 between the approximate times of 12:00 midnight and 2:17 a.m., O & Y, INC. dba SANDY'S LOUNGE, a dispenser general licensee, did, through its employee, sell, serve, or furnish liquor to a minor, as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, contrary to Section 281-78(b)(1)(A) of the Hawaii Revised Statutes and Section 08-101-60(b)(1)(A) of the Rules of the Liquor Commission, County of Maui.

Count 3. On April 4, 2013 between the approximate times of 12:00 midnight and 2:17 a.m., O & Y, INC. dba SANDY'S LOUNGE, a dispenser general licensee, did, through its employee(s), sell, serve, or furnish liquor to, or allow the consumption of liquor by a patron, who was at the time under the influence of liquor, as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, contrary to Section 281-78(b)(1)(B) of the Hawaii Revised Statutes and Section 08-101-60(b)(1)(B) of the Rules of the Liquor Commission, County of Maui.

Count 6. On April 4, 2013 between the approximate times of 12:00 midnight and 2:17 a.m., O & Y, INC. dba SANDY'S LOUNGE, a dispenser general licensee, did fail to exercise due care to ensure that no person or employee, while on duty, be permitted to consume any alcoholic beverages, contrary to Section 08-101-80(a)(1) of the Rules of the Liquor Commission, County of Maui.

D. COMPLAINT AND ACCUSATION NO. 2015-17, PLEA: NO CONTEST

In the matter of the accusation against LAHAINA PETROLEUM, LLC dba LAHAINA CHEVRON, Retail Beer and Wine License No. 381, 240 Papalaua Street, Lahaina, Maui, Hawaii.

Count 1. On July 12, 2013 at approximately 4:58 p.m., LAHAINA PETROLEUM, LLC dba LAHAINA CHEVRON, a retail beer and wine licensee, did, through its employee, sell or furnish liquor to a minor, as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, contrary to Section 281-78(b)(1)(A) of the Hawaii Revised

Statutes and Section 08-101-60(b)(1)(A) of the Rules of the Liquor Commission, County of Maui.
