AMENDING CHAPTER 2.96, RESIDENTIAL WORKFORCE HOUSING POLICY (HHT-6)

DESCRIPTION:

The Committee is in receipt of the following:

1. County Communication 15-93, from the Director of Housing and Human Concerns, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING CHAPTER 2.96, MAUI COUNTY CODE, RELATING TO THE RESIDENTIAL WORKFORCE HOUSING POLICY CREDITS AND FORECLOSURES". The purpose of the proposed bill is to provide clarification specific to Sections 2.96.050 and 2.96.060, Maui County Code ("MCC"), relating to credits and foreclosures.
2. Correspondence dated June 2, 2015, from the Director of Housing and Human Concerns, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING CHAPTER 2.96, MAUI COUNTY CODE, RELATING TO THE RESIDENTIAL WORKFORCE HOUSING POLICY AND CHAPTER 201H HAWAII REVISED STATUTES PROJECTS". The purpose of the proposed bill is to provide clarification specific to Section 2.96.030, MCC, to state that in the event that the terms in Chapter 201H, Hawaii Revised Statutes ("HRS"), and Chapter 2.96, MCC, are in conflict, the terms contained in Chapter 201H, HRS, shall control.

STATUS:

The Committee may consider whether to recommend passage of the revised proposed bills on first reading, with or without revisions. The Committee may also consider the filing of County Communication 15-93 and other related action.
