### **VEHICLE WINDSHIELD REQUIREMENTS (IEM-21)**

**DESCRIPTION:** The Committee is in receipt of County Communication 15-106, from Councilmember Cochran, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING SECTION 10.20.420, MAUI COUNTY CODE, RELATING TO VEHICLE WINDSHIELD REQUIREMENTS". The purpose of the proposed resolution is to authorize the exchange of 15.9548 acres of County real property with 15.6726 acres of real property from Lanai Resorts, LLC, in Lanai, Hawaii, to provide the County fee simple title to the real property upon which the existing Kaupili Road is situated.
