DONATION OF A BATTING CAGE AT KALAMA PARK (KIHEI) (EAR-40)

DESCRIPTION: The Committee is in receipt of a County Communication 15-213, from the Director of Parks and Recreation, transmitting a proposed resolution entitled "AUTHORIZING ACCEPTANCE OF A DONATION OF A BATTING CAGE TO THE DEPARTMENT OF PARKS AND RECREATION, COUNTY OF MAUI, PURSUANT TO CHAPTER 3.56, MAUI COUNTY CODE."
