#### **WELLHEAD PROTECTION OVERLAY DISTRICT (WR-1)**

**DESCRIPTION:**

The Committee is in receipt of the following:

1. County Communication 15-50, from the Director of Water Supply, transmitting a proposed bill to establish a Wellhead Protection Overlay District.
2. Correspondence dated February 23, 2015, from the Department of the Corporation Counsel, transmitting a proposed resolution entitled "REFERRING TO THE LANAI, MAUI, AND MOLOKAI PLANNING COMMISSIONS A PROPOSED BILL AMENDING TITLE 19, MAUI COUNTY CODE, RELATING TO WELLHEAD PROTECTION." The purpose of the proposed resolution is to refer to the planning commissions a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING TITLE 19, MAUI COUNTY CODE, TO ESTABLISH A WELLHEAD PROTECTION OVERLAY DISTRICT." The purpose of the proposed bill is to establish a Wellhead Protection Overlay District to: (1) protect the public's health, welfare, and safety by minimizing the risks of contamination of aquifers; (2) preserve and protect existing and potential drinking water sources; (3) implement land use policies consistent with the General Plan; and (4) prohibit land uses that are incompatible with groundwater protection.

**STATUS:**

The Committee may consider whether to recommend adoption of the proposed resolution, with or without revisions, and other related action.
