BABY DIAPER-CHANGING ACCOMMODATIONS (HHT-25)

DESCRIPTION:

The Committee is in receipt of the following:

1. County Communication 15-240, from Councilmember Elle Cochran, transmitting a proposed bill to require baby diaper-changing accommodations for certain new establishments and uses.
2. Correspondence dated October 8, 2015, from the Department of the Corporation Counsel, transmitting a revised proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING TITLE 8, MAUI COUNTY CODE, RELATING TO REQUIREMENTS FOR BABY DIAPER-CHANGING ACCOMMODATIONS FOR CERTAIN NEW ESTABLISHMENTS AND USES." The revised proposed bill incorporates nonsubstantive revisions.
