AMENDING THE ACQUISITION AND DISPOSITION REQUIREMENTS PERTAINING TO INFRASTRUCTURE-RELATED REAL PROPERTY (IEM-60)

DESCRIPTION:

The Committee is in receipt of the following:

1. County Communication 13-34, from Councilmember Michael P. Victorino, transmitting a proposed bill relating to the conveyance of road-widening lots and related easements.
2. County Communication 14-187, from the Director of Public Works, transmitting a proposed bill relating to the conveyance, exchange, and appraisal requirements pertaining to infrastructure-related property.
3. Correspondence dated November 24, 2015, from the Department of the Corporation Counsel, transmitting a revised proposed bill, entitled "A BILL FOR AN ORDINANCE TO AMEND THE ACQUISITION, EXCHANGE, AND APPRAISAL REQUIREMENTS PERTAINING TO REAL PROPERTY AND EASEMENTS." The purpose of the proposed bill is to improve the County's infrastructure by authorizing the Administration to acquire, without Council approval: (1) real property for a purchase price that does not exceed \$250,000; (2) certain housing units for a purchase price of \$500,000 or less; and (3) infrastructure-related real property and easements.

STATUS:

The Committee may consider whether to recommend passage of the revised proposed bill on first reading, with or without further revisions. The Committee may also consider the filing of County Communications 13-34 and 14-187 and other related action.

STORMWATER UTILITIES (IEM-44)

DESCRIPTION:

The Committee is in receipt of County Communication 15-276, from Councilmember Baisa, transmitting the matter of stormwater utilities.
