A. COMPLAINT AND ACCUSATION NO. 2013-38, PLEA: NO CONTEST

In the matter of the accusation against KAYA, INC. dba MIMI'S LOUNGE, Dispenser General License No. 013, 1063 Lower Main Street, C-103 & C-104 Wailuku, Maui, Hawaii.

Count 1. On July 20, 2012 at approximately 11:41 p.m., KAYA, INC. dba MIMI'S LOUNGE, a dispenser general licensee, did, through its employee, sell, serve, or furnish liquor to a minor, as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, contrary to Section 281-78(b)(1)(A) of the Hawaii Revised Statutes and Section 08-101-60(b)(1)(A) of the Rules of the Liquor Commission, County of Maui.

Count 2. On July 20, 2012 at approximately 11:41 p.m., KAYA, INC. dba MIMI'S LOUNGE, a dispenser general licensee, did, through its employee, fail to properly check the identification of a minor, as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, contrary to Section 08-101-61(c) of the Rules of the Liquor Commission, County of Maui.

B. COMPLAINT AND ACCUSATION NO. 2015-20, PLEA: NOT GUILTY

In the matter of the accusation against L.L.B. ENTERPRISE LLC dba STEEL HORSE SALOON, Dispenser General License No. 042, 1234 Lower Main Street, Wailuku, Maui, Hawaii.

Count 1. On September 28, 2014 between the approximate times of 10:30 p.m. and 11:45 p.m., L.L.B. ENTERPRISE LLC dba

STEEL HORSE SALOON, a dispenser general licensee, did, through its employee(s), sell, serve, or furnish liquor to, or allow the consumption of liquor by a patron, who was at the time under the influence of liquor, as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, contrary to Section 281-78(b)(1)(B) of the Hawaii Revised Statutes and Section 08-101-60(b)(1)(B) of the Rules of the Liquor Commission, County of Maui.

Count 2. On September 28, 2014 between the approximate times of 10:30 p.m. and 11:45 p.m., L.L.B. ENTERPRISE LLC dba STEEL HORSE SALOON, a dispenser general licensee, did, through its employee(s), fail to exercise due care, as defined in Section 08-101-5 of the Rules of the Liquor Commission, in determining whether a patron was under the influence of liquor, as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, contrary to Section 08-101-60(b)(11) of the Rules of the Liquor Commission, County of Maui.

Count 3. On September 28, 2014 between the approximate times of 10:30 p.m. and 11:45 p.m., L.L.B. ENTERPRISE LLC dba STEEL HORSE SALOON, a dispenser general licensee, did, through its employee(s), knowingly permit a patron, who was at the time under the influence of liquor, as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, to be or remain in or on the licensed premises, contrary to Section 281-78(b)(5) of the Hawaii Revised Statutes and Section 08-101-60(b)(5) of the Rules of the Liquor Commission, County of Maui.
