#### **CHANGE IN ZONING FOR WEYMOUTH KAMAKANA, SR. (KAWELA) (LU-16)**

**DESCRIPTION:**

The Committee is in receipt of the following:

1. County Communication 15-215, from Councilmember Stacy Crivello, transmitting a proposed resolution to refer to the Molokai Planning Commission a proposed bill to grant a Change in Zoning from Interim District to Agricultural District for 14.59 acres at Kawela, Molokai, Hawaii, identified for real property tax purposes as tax map key (2) 5-4-001:029 ("property").
2. Correspondence dated January 15, 2016, from the Planning Director, transmitting the Molokai Planning Commission's findings and recommendations on the proposed Change in Zoning bill referred by Resolution 15-111.
3. Correspondence dated March 4, 2016, from the Department of the Corporation Counsel, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE TO CHANGE ZONING FROM INTERIM DISTRICT TO R-3 RESIDENTIAL DISTRICT (CONDITIONAL ZONING) FOR 14.59 ACRES AT KAWELA, MOLOKAI, HAWAII." The purpose of the proposed bill is to grant a request for a Change in Zoning from Interim District to R-3 Residential District for the property, consistent with the Molokai Planning Commission's recommendations.
