#### STATE OF HAWAII'S TRANSIENT ACCOMMODATIONS TAX (PIA-57)

**DESCRIPTION:**

The Committee is in receipt of the following:

1. County Communication 15-254, from Council Chair Mike White, relating to the State of Hawaii's transient accommodations tax.
2. County Communication 16-2, from Council Chair Mike White, transmitting a proposed resolution entitled "URGING THE LEGISLATURE TO PROVIDE THE COUNTIES WITH THE SAME SHARE OF TRANSIENT ACCOMMODATIONS TAX REVENUE AS THE STATE." The purpose of the proposed resolution is to urge the State Legislature to enact legislation providing the counties with the same share of transient accommodations tax revenue as the State.
