AGRICULTURAL WATER RATES FOR THE UNIVERSITY OF HAWAII COLLEGE OF TROPICAL AGRICULTURE AND HUMAN RESOURCES (CTAHR) (WR-15)

DESCRIPTION: The Committee is in receipt of County Communication 15-297 from Councilmember Gladys C. Baisa, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE TO AUTHORIZE AGRICULTURAL WATER RATES FOR PROPERTIES OWNED, OPERATED, OR MANAGED BY THE UNIVERSITY OF HAWAII COLLEGE OF TROPICAL AGRICULTURE AND HUMAN RESOURCES." The purpose of the proposed bill is to authorize agricultural water rates for properties owned, operated, or managed by the University of Hawaii's College of Tropical Agriculture and Human Resources.
