Count 1. On June 20, 2015 at approximately 6:21 p.m., 90210 MANAGEMENT COMPANY, LLC dba WAILEA GIFT SHOP, a retail general licensee, did, through its employee, sell or furnish liquor to a minor, as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, contrary to Section 281-78(b)(1)(A) of the Hawaii Revised Statutes and Section 08-101-60(b)(1)(A) of the Rules of the Liquor Commission, County of Maui.

B. COMPLAINT AND ACCUSATION NO. 2016-4, PLEA: NO CONTEST

In the matter of the accusation against S&M WAILEA LLC dba MALA WAILEA, Restaurant General License No. 207, 3700 Wailea Alanui Drive, Wailea, Maui, Hawaii.

Count 1. On July 11, 2015 at approximately 9:13 p.m., S&M WAILEA LLC dba MALA WAILEA, a restaurant general licensee, did, through its employee, sell, serve, or furnish liquor to a minor, as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, contrary to Section 281-78(b)(1)(A) of the Hawaii Revised Statutes and Section 08-101-60(b)(1)(A) of the Rules of the Liquor Commission, County of Maui.
