CHAIR TAKITANI: Good afternoon. And Clarita Balala, Committee Secretary. Our offices out in Hana, Dawn Lono; Lanai is Denise Fernandez; and on Molokai is Ella Alcon. And before we begin we want to mahalo the Mayor for letting us use this nice room. At this point we'd like to proceed if there is any public testimony. Ms. Willenbrink.

MS. WILLENBRINK: Thank you, Chair. For those who will be testifying here in the Mayor's Lounge, please sign up at the desk. If you will be testifying from one of the remote testimony locations specified on the meeting agenda, please sign up with district office staff at that location. Testimony is limited to three minutes. At two and a half minutes, I will let you know that you have thirty seconds to conclude. MS. WILLENBRINK: Thank you. Lanai Office, is there anyone wishing to testify?

MS. FERNANDEZ: Good afternoon, Chair. This is Denise Fernandez on Lanai and there is no one waiting to testify.

MS. WILLENBRINK: Chair, I do not have any testimony forms in front of me. Do we have any testifiers? There's no one waiting to testify.

CHAIR TAKITANI: Paul, that question was directed at you. . . *(laughter)* . . .

MR. JANES-BROWN: I'm just here to watch. I've said everything I have to say. You guys did a great job. That's all I can say.

CHAIR TAKITANI: Okay. If there are no objections, I'd like to now close public testimony. So, therefore, testimony is now closed. As you recall, we set up a...this Committee set up a five-member TIG, Temporary Investigative Group, on March 31st of this year to recommend three structures for county manager form of government. Members of the TIG were Kimo, who we appointed as Chair, Jonathan, Kehau, Ray, and Tamara. They were charged with reporting their findings and recommendations to the Committee today. Section 92-2.5 of the HRS requires that deliberation and decision making on their report, if any, can occur only at a duly noticed meeting of the Committee held subsequent to the meeting at which the findings and recommendations of the TIG are presented. I think in English that means we can't talk about it today. It's the Chair's intent to simply receive the TIG report today and I ask that you reserve questions and comments for our next meeting that is scheduled for April 29th in the Planning Conference Room in the building next door. The TIG report—is this it?—has been submitted to me and I will ask Ms. Willenbrink to pass it out to all the Members. And if anyone in the public would like a copy, I'm sure we can get you one. Is there anyone? . . . *(laughter)* . . . You got it.

MR. JANES-BROWN: Thank you.

CHAIR TAKITANI: And also for the record, this report will also be uploaded to the Council website at the mauicounty.us. Is it .us, .gov, or? Anyway, it's at the mauicounty website and there's a link to the new Granicus website. Is that correct? It should be available electronically in a very few moments so it is out there for the public who is watching this live across the world. . . *(laughter)* . . . And thank you very much, Kim, for passing that out and thank you, Members, for preparing the report. At our next meeting we hope to be discussing the findings and the recommendations. Any questions for what was covered to this point because we're pretty much set to adjourn.

MEMBER OKAMOTO: Is the meeting...is the 29th meeting set in stone? I know I can't come.

MS. WILLENBRINK: I believe we have quorum. Does...is Kay listed on your? We have you as not available.


