Chair and Members:

Your Budget and Finance Committee, having met on August 2, 2016, makes reference to County Communication 16-145, from the Budget Director, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2017 BUDGET FOR THE COUNTY OF MAUI AS IT PERTAINS TO APPENDIX A, PART I, GRANT REVENUE – SCHEDULE OF GRANTS BY DEPARTMENTS AND PROGRAMS, DEPARTMENT OF ENVIRONMENTAL MANAGEMENT (GLASS RECOVERY PROGRAM)."

The purpose of the proposed bill is to amend Appendix A of the Fiscal Year 2017 Budget by increasing the grant for the Department of Environmental Management, Glass Recovery Program, by \$16,100. The grant is from the State of Hawaii, Department of Health, in the amount of \$99,100.

Your Committee notes pursuant to Chapter 342G, Hawaii Revised Statutes, the State's Advance Disposal Fee Program charges a fee on glass containers, except for beverage containers covered by the State's Deposit Beverage Container Program and certain other containers. A fee of one and one-half cents per container is collected, and the funds are distributed to the counties for programs to divert glass from landfills.

A representative from the Department of Environmental Management said the grant will be used to continue the County's Glass Recovery Program. The program compensates haulers and recycling processors of glass containers from businesses.

Your Committee voted 8-0 to recommend passage of the proposed bill on first reading and filing of the communication. Committee Chair Hokama, Vice-Chair White, and members Baisa, Carroll, Cochran,


Couch, Crivello, and Guzman voted “aye.” Committee member Victorino was excused.

(GLASS RECOVERY PROGRAM)

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Ordinance No. 4334, Bill No. 62 (2016), Draft 1, as amended, "Fiscal Year 2017 Budget", Appendix A, Part I, Grant Revenue - Schedule of Grants by Departments and Programs for Fiscal Year 2017, is hereby amended as it pertains to the Department of Environmental Management, by increasing the appropriation for the Glass Recovery Program, in the amount of \$16,100, to read as follows:

"2. Department of Environmental Management

a. Department of Health West Maui Public Outreach Grant		50,000
b. Glass Recovery Program	[83,000]	<u>99,100</u>
c. Recycling Program - Landfill Diversion		300,000"

SECTION 2. Material to be repealed is bracketed. New material is underscored.

SECTION 3. This Ordinance shall take effect upon its approval.
