Chair and Members:

Your Policy and Intergovernmental Affairs Committee, having met on August 29, 2016, makes reference to County Communication 15-5, from Councilmember Mike White, relating to nominations to boards, committees, and commissions.

By correspondence dated and received August 12, 2016, the Mayor transmitted a proposed resolution, entitled "RELATING TO THE APPOINTMENT OF DOREEN CANTO TO THE MAUI PLANNING COMMISSION," along with a completed application form for the nominee.

The purpose of the proposed resolution is to approve or disapprove the appointment of Doreen Canto to the Maui Planning Commission, for a term expiring on March 31, 2018, to fill a vacancy due to the death of Jason Medeiros.

Your Committee notes general appointment procedures for the Commission are provided in Section 13-2, Revised Charter of the County of Maui (1983), as amended, and Chapter 2.41, Maui County Code. Specific provisions for the Commission are provided in Charter Section 8-8.4 and Section 2.28.010, MCC.

Your Committee further notes the Council must approve or disapprove the nomination by October 11, 2016, or the nomination will be deemed approved.

In an interview with your Committee, Ms. Canto stated she is committed to attending Commission meetings and fulfilling her responsibilities on the Commission.

WHEREAS, by correspondence dated August 12, 2016, Mayor Alan M. Arakawa notified the Council he nominated Doreen Canto to the Maui Planning Commission for a term expiring March 31, 2018, to fill a vacancy replacing Jason Medeiros, pursuant to Section 2.28.010, Maui County Code, and Sections 8-8.4 and 13-2, Revised Charter of the County of Maui (1983), as amended, ("Charter"); and


WHEREAS, Charter Section 13-2, requires the Mayor's nominee to be approved by the Council; and

WHEREAS, Charter Section 13-2(17), requires the Council to approve or disapprove the nomination within sixty days after the Mayor submits the name of the nominee to the Council because of the death, resignation, or removal of a member; now, therefore,

BE IT RESOLVED by the Council of the County of Maui:

1. That it approves the appointment of Doreen Canto to serve on the Maui Planning Commission for a term expiring March 31, 2018;
2. That the Council expresses its gratitude and appreciation to Doreen Canto for her willingness to be considered for public service and actively participate in County government; and
3. That certified copies of this Resolution be transmitted to the Mayor, the Managing Director, and the Corporation Counsel.
