NOMINATIONS TO BOARDS, COMMITTEES, AND COMMISSIONS (LANAI PLANNING COMMISSION) (PIA-2(29))

DESCRIPTION: The Committee is in receipt of correspondence dated September 14, 2016 (received September 14, 2016), from the Mayor, transmitting a proposed resolution, entitled "RELATING TO THE APPOINTMENT OF CARON GREEN TO THE LANAI PLANNING COMMISSION," along with a completed application form for the nominee. The purpose of the proposed resolution is to approve or disapprove the appointment of Caron Green to the Lanai Planning Commission, for a term expiring on March 31, 2020, to fill a vacancy due to the resignation of Jarrod Barfield.

STATUS: The Council must approve or disapprove the nomination by November 13, 2016, or the nomination will be deemed approved. The Committee may consider whether to recommend adoption of the proposed resolution, with or without revisions. The Committee may also consider other related action.

PROTECTING AND PRESERVING PUBLIC HEALTH, SAFETY, AND WELFARE (PIA-61)

DESCRIPTION: The Committee is in receipt of County Communication 15-296, from the Mayor, transmitting five proposed bills, including a bill entitled "A BILL FOR AN ORDINANCE AMENDING TITLE 8, MAUI COUNTY CODE, BY ADDING PROHIBITIONS RELATING TO LYING DOWN ON PUBLIC SIDEWALKS." The purpose of the proposed bill is to amend the Maui County Code to prohibit a person from lying down on a public sidewalk.

STATUS: The Committee may consider whether to recommend passage of the proposed bill on first reading, with or without revisions. The Committee may also consider the filing of County Communication 15-296 and other related action.
