The purpose of the Public Participation Plan (PPP) is to identify the methods and processes for engaging interested parties and the general public in the development of the MPO's Long Range Transportation Plan, Transportation Improvement Program, and various planning studies. The public will have a 45 day period to review and provide comments on the draft PPP, once the Policy Board approves the public review draft.

Requested action: Recommend Policy Board approval of public review draft.

b. Review draft Mode Shift legislation

Blue Planet Foundation is requesting comments on a draft mode share bill proposal for the 2017 Legislative session. The bill creates a statewide target to have less than half of all trips statewide be by automobiles by the year 2040 and then directs the counties and MPOs to create and incorporate mode share targets for the years 2025 to 2040 into all future County general, community development, land use and transportation plans.

Requested action: Provide comments on draft bill for Policy Board consideration.

c. Discuss idea of Peer-to-Peer Exchange with County of Kaua'i

An action item identified at the Sustainable Transportation Forum on December 7, 2016 was for Maui County to host a peer-to-peer exchange with Kaua'i County to share strategies for planning and implementing Complete Streets. The exchange would involve a staff-level workshop and design charrette as well as a public event.

Requested action: Discuss goals and objectives of the peer-to-peer exchange.

d. Public comments

On December 20, 2016 the MPO Director attended a meeting of the Pa'ia Community Action Committee. They strongly support moving forward with development of the Pa'ia Relief Route and are willing to build community support around a to-be-determined preferred alignment. Several possible alignments were considered in 2009 by the Pa'ia Relief Route Advisory Group. A Draft EIS for the project is planned for public release in mid-2017.
