Chair and Members:

Your Budget and Finance Committee, having met on January 31, 2017, makes reference to County Communication 17-47, from the Budget Director, transmitting the following:

1. A proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2017 BUDGET FOR THE COUNTY OF MAUI AS IT PERTAINS TO ESTIMATED REVENUES; DEPARTMENT OF ENVIRONMENTAL MANAGEMENT, WASTEWATER OPERATIONS PROGRAM – SEWER FUND, ENVIRONMENTAL PROTECTION AND SUSTAINABILITY PROGRAM – SOLID WASTE MANAGEMENT FUND; TOTAL OPERATING APPROPRIATIONS; AND TOTAL APPROPRIATIONS (OPERATING AND CAPITAL IMPROVEMENT PROJECTS)."

The purpose of the proposed bill is to amend the Fiscal Year 2017 Budget by 1) increasing the estimated revenues for Interfund Transfers by \$201,307; 2) increasing Carryover/Savings from the Sewer Fund by \$201,307; 3) amending Section 3.B.3.c., Department of Environmental Management, by increasing the Wastewater Operations Program – Sewer Fund by \$201,307 under Category B (Operations), and adjusting the total accordingly; and 4) amending Section 3.B.3.f., Department of Environmental Management, by increasing the Environmental Protection and Sustainability Program – Solid Waste Management Fund, by \$201,307 under Category B (Operations), and adjusting the total accordingly.

2. A Certification of Additional Revenues for Fiscal Year 2017, dated January 13, 2017, for \$201,307 in Carryover/Savings from the Sewer Fund.

By correspondence dated January 24, 2017, the Budget Director transmitted a revised proposed bill to amend the Fiscal Year 2017 Budget by 1) increasing the estimated revenues for Interfund Transfers by \$201,307; 2) increasing Carryover/Savings from the Sewer Fund by \$201,307; 3) increasing Carryover/Savings from the Solid Waste Management Fund by \$429,737; 4) amending Section 3.B.3.c., Department of Environmental Management, by increasing the Wastewater Operations Program – Sewer Fund, by \$201,307 under Category B (Operations), and adjusting the total accordingly; and 5) amending Section 3.B.3.f., Department of Environmental Management, by increasing the Environmental Protection and Sustainability Program – Solid Waste Management Fund, by \$20,000 under Category A (Salaries), and \$611,044 under Category B (Operations), and adjusting the appropriation totals accordingly.

Your Committee notes Ordinance 4356, Bill 85 (2016), amended Appendix B of the Fiscal Year 2017 Budget relating to fees for biosolids from \$90 to \$103 per ton; uncontaminated greenwaste from \$25 to \$36 per ton, and grease trap waste or contaminated cooking oil from \$67 to \$30 per ton.

The Deputy Director of Environmental Management said the Wastewater Division estimated the cost of sludge disposal at \$90 per ton, and upon increase of the fee, the budget was not adjusted to account for the additional cost. The proposed amendment of \$201,307 would properly account for expenditures related to sludge disposal for the Wastewater Reclamation Division and the Solid Waste Management Division.

He said the Department projects a shortfall for waste-processing contractual services for Fiscal Year 2017. He informed your Committee the bids for the following contracts were higher than anticipated: (1) EKO Systems, Inc., dba Maui EKO Systems, by \$459,169; and (2) Used Motor Oil contract by \$126,875.

He said the Used Motor Oil Program has been temporarily discontinued because of insufficient funds. Malama Maui Nui has determined the program does not meet the core values of their organization and no longer provides the service. If the proposed amendment is approved, the program will be reinstated for the remainder of the fiscal year. Until such time, the Environmental Protection and Sustainability Division is asking the public to hold on to their used motor oil and not dispose it at the landfill.

The Deputy Director explained the request for \$20,000 for salaries and fringe benefit costs is for an unfunded Recycling Specialist IV position included in the Fiscal Year 2017 Budget. He said the position will be downgraded to a Recycling Specialist II to support the Abandoned Vehicle and Metals Program. In anticipation of approval of the proposed amendment, a redescription of the position has been prepared and the Division may consider an emergency hire until the end of the fiscal year.

Your Committee notes pursuant to Section 8-15.3(4) of the Revised Charter of the County of Maui (1983), as amended, the Director of Environmental Management shall "Guide efforts to optimize opportunities for environmental, natural resource protection, sustainability, conservation, and restoration."

Your Committee questioned the 2013 amendment to the County Charter relating to environmental protection and sustainability. The Deputy Director responded he has been tasked with overseeing the Division and feels the duties and functions of the Charter requirement relate to more than just the Department of Environmental Management. The matter relating to environmental protection and sustainability should be discussed further in the appropriate standing committee.

Your Committee voted 8-0 to recommend passage of the revised proposed bill on first reading and filing of the communication. Committee Chair Hokama, Vice-Chair White, and members Atay, Carroll, Crivello, Guzman, King, and Sugimura voted "aye." Committee member Cochran was excused.



BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1.
