PUBLIC HEARING HELD ON

MAY 12, 2017

THE COUNCIL OF THE COUNTY OF MAUI, STATE OF HAWAII, CONVENED A PUBLIC HEARING ON FRIDAY, MAY 12, 2017, AT 10:03 A.M., IN THE COUNCIL CHAMBER, KALANA O MAUI BUILDING, WAILUKU, HAWAII WITH CHAIR MICHAEL B. WHITE PRESIDING, FOR THE PURPOSE OF RECEIVING TESTIMONY, PURSUANT TO SECTION 249-13, HAWAII REVISED STATUTES, AND SECTION 3.24.030, MAUI COUNTY CODE, REGARDING THE MOTOR VEHICLE WEIGHT TAX RATES FOR FISCAL YEAR 2018.

CHAIR WHITE: This public hearing of the Maui County Council shall please come to order.

Members, as you know, the purpose of this public hearing is to receive public testimony pursuant to Section 249-13 of Hawaii Revised Statutes, and Section 3.24.030 of the Maui County Code, regarding the Motor Vehicle Weight Tax rates for the Fiscal Year 2018.

Effective January 1, 2018, \$0.04 (four cents) per pound of net weight for passenger vehicles, and trucks and noncommercial vehicles exceeding 6,500 pounds. And that rate is currently \$0.03.

Effective January 1, 2018, \$0.0636 (six and thirty-six hundredths cents) per pound of net weight for all motor vehicles. And that is, that rate is currently \$0.0436.

And a minimum tax for any motor vehicle of \$12.00. Penalty for delinquent tax is \$8 for passenger vehicles and, or \$20 for other vehicles. No changes in those two items are being made.

So with that, Mr. Clerk, please call the roll.

CHAIR WHITE: Thank you, Mr. Clerk.

And Members, all, please remember to silence your cellphones, and that goes to the folks in the, in the chambers as well.

Mr. Clerk, please proceed.

COUNTY CLERK: Mr. Chair, proceeding with the presentation of testimony on the agenda item.

Subject: Vehicle license fees

I see that once again the county is attempting to raise the vehicle license fees. We own several semi trucks as well as the trailers that they pull; plus pickup trucks. The fees for one semi with a trailer is approximately \$2200.00 per year- Some companies can't afford it so they put the vehicles in storage so you lose more of it. I have asked the MPD regarding my question, they say it's up to DMV; DMV says it is up to MPD. I have written to the governor and KHON2 has been given this information. Here is the question you need to look into. When someone purchases a truck or a cargo van, they are required to sign a legal document stating that it will not be used for commercial or business use. They pay the non-commercial rates which are much less than the commercial plates, (commercial plates have the numbers first and then the letters). They then go and have their business name put on the vehicles. Why are they not sited somehow? How about when they go to get their safety check? The name on the registration doesn't match what is on the truck. I took someone to get their drivers license once with my car. The insurance was under the company name; the car was under my name. They refused to let them use the car until the two items matched. When they are doing seat belt checks; they could check for that. Just drive around and see how many hundreds of vehicles you see. If they would pay their fair share; you could let those of us that already pay such high fees not have to bear the burden of the illegal vehicles on the roads.
