WATER SERVICES (WR-20)

Description: The Committee is in receipt of the following:

1. County Communication 16-40, from the Director of Water Supply, transmitting a proposed bill relating to cross-connection control, backflow prevention, and installation of fire water service.
2. Water Resources Committee Report 16-156 (recommitted), recommending passage on first reading of a proposed bill requiring installation of backflow preventers on premises to prevent the backflow of possible contaminated water into the County's water system.
3. Correspondence dated September 21, 2016, from the Department of the Corporation Counsel, transmitting a revised proposed bill, entitled "A BILL FOR AN ORDINANCE AMENDING TITLE 14, ARTICLE 1, MAUI COUNTY CODE, RELATING TO CROSS-CONNECTION AND BACKFLOW CONTROL AND WATER FOR FIRE SERVICE." The purpose of the revised proposed bill is to require consumers and owners of real property to install a backflow preventer on properties connected to the Department's water system, prohibit certain connections and installations that could contaminate the Department's water system, and establish provisions for fire water service installations.
4. A presentation dated May 17, 2017, from the Director of Water Supply, relating to backflow preventers.
