AMENDING CHAPTERS 16.18B, 16.20B, AND 16.26B, MAUI COUNTY CODE, RELATING TO DEPARTMENT OF PUBLIC WORKS FEE AMOUNTS OR RATES (IEM-47)

Description: The Committee is in receipt of County Communication 17-362, from the Director of Public Works, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING CHAPTERS 16.18B, 16.20B, AND 16.26B, MAUI COUNTY CODE, RELATING TO FEES." The purpose of the proposed bill is to remove specific Department of Public Works fee amounts from the Electrical Code, Plumbing Code, and Building Code, and instead refer to the fees as set forth in the annual budget ordinance.
