On August 12, 2017 at approximately 10:54 p.m., HAOLEPINOS OF MAUI, INC. dba 7 POOLS LOUNGE, a dispenser general licensee, did fail to obtain a permit for the installation of two video game devices, contrary to Section 08-101-27(a)(4) of the Rules of the Liquor Commission, County of Maui.
