AMENDING SECTION 20.40.020, MAUI COUNTY CODE, RELATING TO THE DEFINITION OF "SAND MINING" (IEM-33)

Description: The Committee is in receipt of County Communication 18-51, from Councilmember Elle Cochran, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE TO AMEND SECTION 20.40.020, MAUI COUNTY CODE, RELATING TO THE DEFINITION OF "SAND MINING."" The purpose of the proposed bill is to amend the definition of "sand mining" by deleting the third exception relating to activities conducted pursuant to a valid permit issued prior to the effective date of the ordinance.
