KA HALE A KE OLA WESTSIDE SHELTER (HHT-20)

Description: The Committee is in receipt of the following:

1. County Communication 17-288, from Councilmember Stacy Crivello, relating to the Ka Hale A Ke Ola Westside Shelter.
2. Correspondence dated February 7, 2018, from the Department of the Corporation Counsel, transmitting a revised proposed resolution entitled "AUTHORIZING REPAYMENT PLAN IN SETTLEMENT OF KA HALE A KE OLA HOMELESS RESOURCE CENTERS, INC.'S OUTSTANDING DEBT RELATED TO THE CONSTRUCTION OF THE KHAKO WESTSIDE FACILITY." The purpose of the revised proposed resolution is to structure a repayment schedule of the \$4,005,000 principal loan amount for the construction of KHAKO Westside Shelter plus all accrued interest to date. The repayment to the County shall be in quarterly installments of \$25,000; additionally, no further interest shall accrue on the outstanding debt.

Status: The Committee may consider whether to recommend adoption of the revised proposed resolution, with or without further revisions. The Committee may also consider the filing of County Communication 17-288 and other related action.

Description: The Committee is in receipt of a Miscellaneous Communication, dated May 22, 2017, from the County Clerk, relating to an evaluation of the proposed new Waihee route and expanded hours for the Kihei Islander, Lahaina Islander, Kihei Villager, Kaanapali Islander, and Napili Islander routes, including estimated implementation costs, schedules, proposed fare increases, and whether such expansion, including bus replacements, are warranted.

Status: The Committee may receive a presentation from Daniel Levy of DanTec Associates, relating to the Waihee Bus Route Study. The Committee may also discuss related issues. No legislative action will be taken.
