Discussion to identify a presentation topic regarding Section 8 Housing and persons with disabilities.</p> <p>Commissioner West informed the Commission that she spoke with the program specialist for the County of Maui Section 8 Housing Choice Voucher Program, Ms. Gail Rumbaoa. Ms. Rumbaoa informed Commissioner West that she would like to attend August's meeting to discuss reasonable accommodations, alternate housing projects, and other potential housing opportunities for persons with disabilities.</p> <p>Commissioner West notified the Commission that she will contact Ms. Rumbaoa to re-confirm her availability for August's meeting.</p> <p>c. Discussion regarding paratransit services and the County of Maui FY2019 budget</p> <p>A brief discussion occurred between members of the Commission as to the intent of agenda item (c), Discussion regarding paratransit services and the County of Maui FY2019 budget. While some meeting attendees believed that Maui Economic Opportunity, Inc. (MEO) was providing a presentation regarding the paratransit program changes, Chair Souza reminded the Commission that the agenda item did not include a presentation. In lieu of a presentation, the Commission was seeking further information about the paratransit policy changes.</p> | |

Ms. Gail Sibonga, MEO's Chief Operating Officer, informed the Commission that Mr. Harry Johnson, MEO's Transportation Director, is unable to attend today's meeting due to a work related conference. Mr. Darren Konno, Transportation Specialist for the County of Maui, informed the Commission that the transportation contract with MEO will change on July 1, 2018. The upcoming changes include the elimination of the monthly pass for paratransit services, and the senior (age 55 plus) monthly pass will increase from \$35.00 to \$45.00. For the paratransit services, fees include a \$2.00 fare per boarding or \$4.00 for an all-day fare pass.

Mr. Oliver Caberto inquired about the monthly student bus pass, and Mr. Konno informed Mr. Caberto and the Commission that the County Council did not discuss the monthly student bus pass. Mr. Caberto also inquired how the County discerns whether a student is active or not, and Mr. Konno shared that the student identification card should have the current school year date printed on the ID card. Mr. Konno also notified the Commission that the monthly senior bus pass was removed in the first reading of the budget, but it was reintroduced in the second reading of the budget with an increased fare. Mr. Konno shared that the County Council did not discuss the topic of raising all bus fares and/or fees.

Ms. Roxann Kehus, representing the State Council on Developmental Disabilities, shared her opinion regarding the removal of the monthly paratransit bus pass. According to Ms. Kehus, the removal of the monthly bus pass will directly affect persons with disabilities under the age of 55, especially those who are low income. At the budget hearings, Ms. Kehus shared her concerns with MEO and the County Council for the developmentally disabled community because of their limited monthly income and the large increase in fare cost (\$120.00 per month versus \$45.00 per month).

Commissioner Azizoltani sought clarification regarding this matter, and Ms. Kehus explained the removal of the monthly paratransit bus pass. Without the pass, Ms. Kehus further explained that individuals with disabilities will need to purchase

a daily fare, while seniors (aged 55 plus) and students will still be able to obtain a monthly pass.

Mr. Caberto expressed his concerns regarding the bus pass decision, especially the negative impact on his life because he cannot afford the daily bus fares. Mr. Konno provided the results of a five-year short-range plan study and an audit of the County's transportation services. The reports identified paratransit service trends throughout the United States, and the report noted that most areas across the United States do not offer a monthly pass. Additionally, Mr. Konno also informed the Commission that the cost for paratransit service is rather high. In order to sustain the service, the County removed the monthly pass for paratransit services.

Commissioner West expressed a concern whether the County Council considered Maui's unique, rural setting. According to Mr. Konno, the County Council did not consider geography with their final budget decision. Commissioner West inquired if there is a subsidy or financial assistance for individuals affected by the new bus fare policy. Mr. Konno informed the Commission that the County does not have the ability to subsidize paratransit cost, but some charitable organizations, churches, and Medicaid will assist consumers with transportation expenses. Mr. Konno also notified the Commission that Maui County provides significant transportation options compared to the neighbor islands, such as Oahu where a large majority of paratransit service operators are private, for-profit businesses.

While Ms. Kehus understands Maui offers more options than the other islands, she expressed her concerns on how the bus fare decision negatively affects the quality of life of the paratransit participants.

Mr. Konno offered information about a new fixed bus route that will commence in the near future. The route will travel to Waihee from the Queen Kaahumanu Center in Kahului five times per day. Since the fixed bus route is expanding, paratransit service will also expand to Waihee.

Per Commissioner West's previous announcement during New Business (b), the presentation is tentatively scheduled for August 2018.

- c. Other suggestions for next meeting's agenda
Status and report by Commissioner Sanches of the recommendation letter to the Mayor to encourage County Departments and Divisions to participate with the State's Department of Vocational Rehabilitation's Summer Youth Employment Program.

Ms. Stone-Walls informed the Commission that July's meeting is too late to discuss this year's Summer Youth Employment Program. If the Commission would like to promote this program, Ms. Stone Walls suggested a tentative agenda item and discussion in March 2019.

Commissioner Azizoltani shared a concern about Maui's growth and the County's plan to accommodate new crosswalks, LED crosswalk lights, and sidewalks. Commissioner Courson shared his concern that the Commission may not have the scope or oversight in such a matter.

Commissioner Azizoltani shared his concerns about the agriculture lots in Launiupoko, especially since there are no sidewalks for pedestrians.

Mr. Konno shared a new alliance, the Maui Metropolitan Planning Organization (Maui MPO), which includes County Council members, department heads, and other key stakeholders. According to the Maui Metropolitan Planning Organization website, the Maui MPO is "a government agency formed per federal regulations in 2016 by the State of Hawaii and County of Maui to facilitate comprehensive
