VISITOR IMPACTS TO COUNTY ENVIRONMENTAL AND INFRASTRUCTURAL RESOURCES (IEM-38)

Description: The Committee is in receipt of the following:

1. County Communication 17-231, from Councilmember Elle K. Cochran, relating to visitor impacts to County environmental and infrastructural resources.
2. Correspondence dated September 11, 2018, from the Department of the Corporation Counsel, transmitting a proposed resolution entitled "URGING THE OFFICE OF ECONOMIC DEVELOPMENT TO REQUIRE THE MAUI COUNTY VISITOR ASSOCIATION TO INCORPORATE SPECIFIC ENVIRONMENTAL ACTION ITEMS INTO GRANT OBJECTIVES." The purpose of the proposed resolution is to urge the Office of Economic Development to require the Maui County Visitor Association to incorporate specific environmental action items into grant objectives, and to urge the Office of Economic Development to submit a detailed grant evaluation to the Council for the grant to the Maui County Visitor Association, pursuant to Section 3.36.120, Maui County Code.

Status: The Committee may consider whether to recommend adoption of the proposed resolution, with or without revisions. The Committee may also consider the filing of County Communication 17-231 and other related action.
