I. HEARINGS BEFORE THE BOARD:

A. COMPLAINT AND ACCUSATION NO. 2018-19, PLEA: NOT GUILTY

In the matter of the accusation against EASY STREET, LLC dba MCGRATH'S HANG LOOSE LOUNGE, Dispenser General License No. 350, 333 Dairy Road, Suite 105, Kahului, Maui, Hawaii.

Count 1. On March 8, 2018, EASY STREET, LLC dba MCGRATH'S HANG LOOSE LOUNGE, a dispenser general licensee, did fail to provide any information, documents, books, or records requested by the commission, board, or the department, contrary to Section 08-101-60(b)(14) of the Rules of the Liquor Commission, County of Maui.

Count 2. On March 8, 2018, EASY STREET, LLC dba MCGRATH'S HANG LOOSE LOUNGE, a dispenser general licensee, did fail to exercise due care to ensure that no person or employee actively engaged in the sale or serving of liquor, or while on duty, be permitted to consume any alcoholic beverages, contrary to Section 08-101-80(a)(1) of the Rules of the Liquor Commission, County of Maui.

B. COMPLAINT AND ACCUSATION NO. 2018-23, PLEA: GUILTY

In the matter of the accusation against FOODS 4 LIFE INC. dba RODEO GENERAL STORE, Retail General License No. 306, 3661 Baldwin Avenue, Makawao, Maui, Hawaii.

Count 1. On February 15, 2018, FOODS 4 LIFE INC. dba RODEO GENERAL STORE, a retail general licensee, did, through its employee(s), sell, serve, or furnish liquor to a minor, as defined in Section 281-1 of the Hawaii Revised Statutes and

Section 08-101-5 of the Rules of the Liquor Commission, contrary to Section 281-78(b)(1)(A) of the Hawaii Revised Statutes and Section 08-101-60(b)(1)(A) of the Rules of the Liquor Commission, County of Maui.

- Count 2. On February 15, 2018, FOODS 4 LIFE INC. dba RODEO GENERAL STORE, a retail general licensee, did, through its employee(s), fail to properly check the identification of a minor, as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, contrary to Section 08-101-61(c) of the Rules of the Liquor Commission, County of Maui.

C. COMPLAINT AND ACCUSATION NO. 2018-24, PLEA: NO CONTEST

In the matter of the accusation against TIKI TIKI THAI CUISINE 2 LLC dba TIKI TIKI THAI CUISINE, Dispenser General License No. 085, 658 Front Street, #145A, Lahaina, Maui, Hawaii.

- Count 1. On May 15, 2018, TIKI TIKI THAI CUISINE 2 LLC dba TIKI TIKI THAI CUISINE, a dispenser general licensee, did, through its employee(s), sell, serve, or furnish liquor to a minor, as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, contrary to Section 281-78(b)(1)(A) of the Hawaii Revised Statutes and Section 08-101-60(b)(1)(A) of the Rules of the Liquor Commission, County of Maui.

- Count 2. On May 15 2018, TIKI TIKI THAI CUISINE 2 LLC dba TIKI TIKI THAI CUISINE, a dispenser general licensee, did, through its employee(s), fail to properly check the identification of a minor, as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, contrary to Section 08-101-61(c) of the Rules of the Liquor Commission, County of Maui.

- A. Department of Liquor Control's Motion for Reconsideration on Complaint and Accusation No. 2018-22, IP 1, LLC dba MONKEYPOD KITCHEN BY MERRIMAN, Restaurant General License No. 033, 10 Wailea Gateway Place, Unit B-201, Wailea, Maui, Hawaii.
