I. HEARINGS BEFORE THE BOARD:

A. COMPLAINT AND ACCUSATION NO. 2018-27, PLEA: NOT GUILTY

In the matter of the accusation against PLEASANT TRAVEL SERVICE dba ROYAL LAHAINA RESORT, Hotel License No. 250, 2780 Kekaa Drive, Kaanapali, Maui, Hawaii.

- Count 1. On January 13, 2018, PLEASANT TRAVEL SERVICE dba ROYAL LAHAINA RESORT, a hotel licensee, did, through its employee(s), fail to ensure that aisles or walkways were cleared of any congestion or blockage which would prevent any person from moving freely within any aisle or walkway, or entry to or exit for the premises, contrary to Section 08-101-90(b) of the Rules of the Liquor Commission, County of Maui.
- Count 2. On January 13, 2018, PLEASANT TRAVEL SERVICE dba ROYAL LAHAINA RESORT, a hotel licensee, did, through its employee(s), allow liquor consumption and/or service within the areas for dancing, music and entertainment, contrary to Section 08-101-99(a)(7) of the Rules of the Liquor Commission, County of Maui.
- Count 3. On January 13, 2018, PLEASANT TRAVEL SERVICE dba ROYAL LAHAINA RESORT, a hotel licensee, failed to have an on-duty employee approved by the director, other than a bartender, capable of maintaining order in any liquor dispensing area at all times whenever public dancing and/or live entertainment is conducted therein, which is contrary to Section 08-101-81(b) of the Rules of the Liquor Commission, County of Maui.
- Count 4. On January 13, 2018, PLEASANT TRAVEL SERVICE dba

ROYAL LAHAINA RESORT, a hotel licensee, did, through its employee(s), serve more than two drinks of any liquor at one time to an individual, contrary to Section 08-101-84(b) of the Rules of the Liquor Commission, County of Maui.

- Count 5. On January 13, 2018, PLEASANT TRAVEL SERVICE dba ROYAL LAHAINA RESORT, a hotel licensee, failed to comply with all conditions placed on any permit issued by the department or the commission, contrary to Section 08-101-27(c) of the Rules of the Liquor Commission, County of Maui.
- Count 6. On January 13, 2018, PLEASANT TRAVEL SERVICE dba ROYAL LAHAINA RESORT, a hotel licensee, failed to have an on-duty employee duly approved by the director in active charge of each premises during all times that such premises is open for business, contrary to Section 08-101-70(a) of the Rules of the Liquor Commission, County of Maui.
- Count 7. On January 13, 2018, PLEASANT TRAVEL SERVICE dba ROYAL LAHAINA RESORT, a hotel licensee, did, through its employee(s), fail to remove all empty glasses and containers by persons serving the customers at the time of and before serving another drink, contrary to Section 08-101-84(e) of the Rules of the Liquor Commission, County of Maui.
- Count 8. On January 13, 2018, PLEASANT TRAVEL SERVICE dba ROYAL LAHAINA RESORT, a hotel licensee, failed to have all managers, assistant managers, supervisory personnel, or any other person, who performs any type of managerial or supervisory functions in conjunction with the operation, maintenance supervision or management of the license premises, directly or indirectly, meet the minimum requirements set forth by the commission to be an "employee approved by the director", contrary to Section 08-101-70(g) of the Rules of the Liquor Commission, County of Maui.
- Count 9. On January 13, 2018, PLEASANT TRAVEL SERVICE dba ROYAL LAHAINA RESORT, a hotel licensee, failed on its

class12, hotel licensed premises, to have an on-duty employee duly approved by the director to be inactive charge and be at each liquor dispensing area at all times whenever there is sale, service, or consumption of liquor, contrary to Section 08-101-70(e) of the Rules of the Liquor Commission, County of Maui.
