### MATTERS WITHIN THE COMMITTEE'S SUBJECT-MATTER JURISDICTION (MAUI INVASIVE SPECIES COMMITTEE AND MOLOKA'I/MAUI INVASIVE SPECIES COMMITTEE) (EACP-17(2))

**Description:** Pursuant to Rule 7(B) of the Rules of the Council, the Committee intends to receive a presentation from the Maui Invasive Species Committee (MISC) and the Moloka'i/Maui Invasive Species Committee (MoMISC) on the status of their efforts to eradicate or mitigate infestations of Coqui Frogs, Little Fire Ants, Miconia, Banana Bunchy Top Virus, and other invasive species; preventative measures being taken; how their organizations' funding is allocated; and other related issues.

**Status:** The Committee may receive a presentation from Adam Radford, MISC Manager, and Lori Buchanan, MoMISC Coordinator, on the scope of the invasive species problem, their work and its efficacy, and other related issues. No legislative action will be taken.
