ACQUISITION OF REAL PROPERTY FROM THE DEPARTMENT OF HAWAIIAN HOME LANDS FOR THE MAHINAHINA WATER TREATMENT FACILITY AND OTHER EXISTING AND PROPOSED INFRASTRUCTURE (WAI-50)

Description: The Committee is in receipt of County Communication 19-330, from the Director of Water Supply, transmitting a proposed resolution entitled "APPROVING THE ACQUISITION OF REAL PROPERTY (LICENSES) FROM THE STATE OF HAWAII, DEPARTMENT OF HAWAIIAN HOME LANDS FOR THE MAHINAHINA WATER TREATMENT FACILITY AND OTHER EXISTING AND PROPOSED WATER INFRASTRUCTURE IN MAHINAHINA AND HONOKOWAI, MAUI, HAWAII." The purpose of the proposed resolution is to authorize the Mayor of the County of Maui to execute all necessary documents approving the acquisition of land in exchange for water service source to Department of Hawaiian Home Lands.

INTERGOVERNMENTAL AGREEMENT WITH THE DEPARTMENT OF HAWAIIAN HOME LANDS, FOR LICENSES FOR MAHINAHINA AND HONOKOWAI (WAI-51)

Description: The Committee is in receipt of County Communication 19-331, from the Director of Water Supply, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AUTHORIZING THE MAYOR OF THE COUNTY OF MAUI TO ENTER INTO AN INTERGOVERNMENTAL AGREEMENT WITH THE STATE OF HAWAII, DEPARTMENT OF HAWAIIAN HOME LANDS (AGREEMENT FOR LICENSES FOR MAHINAHINA AND HONOKOWAI)." The purpose of the proposed bill is to allow the Department of Water Supply to secure the necessary easements related to the West Maui Water Source Development Project.

Status: The Committee may consider whether to recommend passage of the proposed bill on first reading, with or without revisions. The Committee may also consider the filing of County Communication 19-331 and other related action.

MAUI ISLAND WATER USE AND DEVELOPMENT PLAN (WAI-37)

Description: The Committee received the following:

1. County Communication 19-162, from the Director of Water Supply, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE ADOPTING AN UPDATE TO THE WATER USE AND DEVELOPMENT PLAN FOR THE ISLAND OF MAUI." Attached to the proposed bill is the updated "Maui Island Water Use and Development Plan Draft," dated March 2019. The purpose of the proposed bill is to adopt the Maui Island Water Use and Development Plan pursuant to Sections 14.02.020 and 14.02.040 (3), Maui County Code.
2. Correspondence dated August 7, 2019, from the Department of the Corporation Counsel, transmitting a revised proposed resolution entitled "APPROVING A TIME EXTENSION FOR THE COUNCIL TO ADOPT THE MAUI ISLAND WATER USE AND DEVELOPMENT PLAN." The purpose of the revised proposed resolution is to provide additional time for the Council to review the Maui Island Water Use and Development Plan.

Status: The Committee may receive a presentation from the Department of Water Supply relating to the Maui Island Water Use and Development Plan and discuss the matter. The Committee may consider whether to recommend adoption of the proposed resolution, with or without further revisions, and other related action.
