### BIENNIAL REVIEW OF RESIDENTIAL WORKFORCE HOUSING POLICY (CHAPTER 2.96, MAUI COUNTY CODE ) (AH-10)

**Description:** The intent of the Residential Workforce Housing Policy is “to encourage the provision and maintenance of residential workforce housing units, for both purchase and rental, to meet the needs of income-qualified households for the workforce, students, and special housing target groups.” Chapter 2.96, Maui County Code, directs the Council to review the Policy every two years.

**Status:** The Committee may review the Residential Workforce Housing Policy and may receive presentations on the development of projects under the Policy. No legislative action will be taken.
