### **RELOCATING THE MOLOKAI POLICE STATION (EDB-42)**

**Description:** The Committee is in receipt of the following:

1. A Miscellaneous Communication, dated May 21, 2019, from the County Clerk, reporting that the Council referred the matter of relocating the Molokai Police Station, including land acquisition, planning, and design.
2. Correspondence dated January 14, 2020, to the Department of the Corporation Counsel, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING ORDINANCE NO. 4985, BILL NO. 34 (2019), RELATING TO THE ISSUANCE OF GENERAL OBLIGATION BONDS OF THE COUNTY OF MAUI ISSUANCE, SALE AND DELIVERY OF SAID BONDS (DEPARTMENT OF POLICE - MOLOKAI POLICE STATION)." The purpose of the proposed bill is to amend the Fiscal Year 2020 general obligation bond authorization ordinance by adding an appropriation for the Molokai Community Plan Area, Government Facilities, for a project entitled "Molokai Police Station," in the amount of \$1,820,000, under the Department of Police.
