KOREANA ARIRANG 1, a dispenser general licensee, failed to exercise due care to ensure that no person or employee actively engaged in the sale or serving of liquor, or while on duty, be permitted to consume any alcoholic beverages, contrary to Section 08-101-80(a)(1) of the Rules of the Liquor Commission,

County of Maui.

Count 2: On December 4, 2018, K.S.K. KOREA, INC. dba CLUB

KOREANA ARIRANG 1, a dispenser general licensee, failed to comply with all conditions placed on any permit issued by the department or the commission, contrary to Section 08-101-27(c)

of the Rules of the Liquor Commission, County of Maui.

Count 3: On December 4, 2018, K.S.K. KOREA, INC. dba CLUB

KOREANA ARIRANG 1, a dispenser general licensee, allowed

the window of an interior room or enclosed area to be tinted, or failed to permit a full view of the interior of an interior room or enclosed area through a transparent window on the entry door and/or on the wall, contrary to Section 08-101-95(a) of the Rules of the Liquor Commission, County of Maui.

  - Count 1: On November 16, 2019, BEACH BUMS, MAALAEA LLC dba BEACH BUMS BAR & GRILL, a dispenser general licensee, failed to exercise due care to ensure that no person or employee actively engaged in the sale or serving of liquor, or while on duty, be permitted to consume any alcoholic beverages, contrary to Section 08-101-80(a)(1) of the Rules of the Liquor Commission, County of Maui.
  - Count 2: On November 16, 2019, BEACH BUMS, MAALAEA LLC dba BEACH BUMS BAR & GRILL, a dispenser general licensee, failed to have an on-duty employee duly approved by the director in active charge of each premises during all times that such premises is open for business, contrary to Section 08-101-70(a) of the Rules of the Liquor Commission, County of Maui.

  - Count 4: On November 16, 2019, BEACH BUMS, MAALAEA LLC dba BEACH BUMS BAR & GRILL, a dispenser general licensee, failed to have the main or primary entrance unlocked while open for business, contrary to Section 08-101-90(a) of the Rules of the Liquor Commission, County of Maui.
