Mariano reported that the letter drafted by Chair West was typed on commission letterhead and mailed to Ms. Kama with copies also mailed to the Mayor, County Chair Alice Lee, Director Lori Tshako and Deputy Director Linda Munsell of Housing and Human Concerns, and Executive Deborah Stone-Walls. Letters were mailed on March 3rd.</p> | <p>Ms. Kama's response. Councilor Oana said "about a month." Matter deferred.</p> |
| <p>5. New Business</p> | <p>A. Presentation- Brian Hauser, Advocacy coordinator, Aloha Independent Living Hawaii, on discrimination against renters using housing vouchers. Mr. Hauser opened with general statistics on Maui's housing voucher system: many experience rejection; about 1489 vouchers were issued by Maui County and only 46% were utilized. Source of income discrimination prohibits a landlord from rejecting tenants based on their lawful source of income. It should clearly identify Section 8 voucher holders. Any legislation should include the education of landlords and real estate associations in order to change the perception of renting to those with housing subsidies.</p> <p>Commissioner Watanabe pointed out that it is hardship for many disabled individuals to make the hearings because the meeting times are too early in the morning and individuals need more time to get ready and to get there. Staff member J. Mariano commented that testimony can be read by a designated proxy.</p> <p>Councilor J. Oana proposed that this body craft a letter to the Mayor suggesting that the county adopt this type of law. If the commission can provide as much information and have the issue directed to the appropriate department(s), then we may see some action. For draft ordinance, it goes to council, then goes to a special committee, and is either passed on or goes nowhere.</p> | <p>Members decided to table the matter for now and to be taken up at another meeting.</p> |
