Members reviewed two sets of proposed mission and vision statements:</p> <p>Commissioner West's proposal, made at the previous meeting:</p> <p><i><u>Mission:</u> To create a community that provides opportunities for independence and full participation in the Maui County Community for individuals with disabilities.</i></p> <p><i><u>Vision:</u> Maui County Community Members with disabilities will live in a community where they are able to safely live, learn, work and participate in recreational and cultural activities</i></p> <p>Vice Chair Copeland's proposed language:</p> <p><i><u>Mission:</u> To make recommendations to the mayor & the council & county officials for policies, programs & systemic changes that maximize independence & community integration for Maui citizens with disabilities & promote compliance with the American Disabilities Act.</i></p> <p><i><u>Vision:</u> Promote & enhance equality of life for Maui citizens with disabilities through advocacy & education by working with our community, elected & other county officials who have the ability to make change.</i></p> <p>No other proposals were made than the two.</p>	<p>The commissioners voted and all selected Vice Chair Copeland's mission and vision statements. Motion to adopt the newly chosen statements by Commissioner West and seconded by Commissioner Kapoi. All in favor; none opposed; motion carried.</p>

Oana asked if the commissioners wanted to have the newly adopted mission and vision statements posted on future agenda <u>and</u> on the Commission's page on the County website.</p>	<p>Vice Chair Copeland made a motion that was seconded by Commissioner Sanches to do both. All in favor; none opposed. Motion carried. Staffer J. Mariano to follow up with both tasks.</p>
<p>5. New Business</p>	<p>A. Update on vacant positions/attendance policy (review) by Ipo Mossman, Mayor's Liaison for Boards and Commissions. Mr. Mossman reported on the two vacant positions on the Commission. Melody Uchimura still has to take the oath and be sworn in as well as complete other paperwork. Ms. Beverly Stanich's nomination went to the GET committee; the Council has to give final approval of her nomination.</p> <p>2.41.090, Maui County Code (amended). The attendance policy was reviewed by Corporation Counsel and Mr. Mossman. The attendance policy that went into place February 2020, which outlines the appointees their responsibility to attend. Attendance is recorded at every meeting, excused or unexcused. All commissioners have a copy of the latest attendance policy in their orientation binder.</p> <p>In response to an inquiry made by Vice Chair Copeland, staffer J. Mariano showed a table summary of the commission meetings held and canceled in 2020. The commission met 7 out of 12 months. The other 5 months were canceled due to lack of quorum. Corporation Counsel J. Oana pointed out that the April 9th mtg was not held specifically due to the stopping of in-person meetings (Mayor's and Governor's mandates) as a result of the pandemic.</p> <p>B.
