DESCRIPTION:

The Committee is in receipt of the following:

- 1. County Communication No. 07-284, from Councilmember Gladys C. Baisa, transmitting a draft bill and draft resolution relating to home occupations.
- 2. Correspondence dated January 2, 2008, from the Committee's Chair, transmitting the following:
 - a. A revised draft bill entitled "A BILL FOR AN ORDINANCE TO AUTHORIZE HOME OCCUPATIONS IN VARIOUS ZONING DISTRICTS". The purpose of the revised draft bill is to establish "home occupation" as a permitted use in the Residential, R-0 Zero Lot Line Residential, Apartment, Country Town Business, B-1 Neighborhood Business, B-2 Community Business, and B-3 Central Business zoning districts.
 - b. A revised draft resolution entitled "REFERRING A DRAFT BILL TO AUTHORIZE HOME OCCUPATIONS IN VARIOUS ZONING DISTRICTS TO THE LANAI, MAUI, AND MOLOKAI PLANNING COMMISSIONS". The purpose of the revised draft resolution is to refer the revised draft bill to the planning commissions.
