### PC-29 BUS STOP PLANNING AND DESIGN

**DESCRIPTION:** The Committee is in receipt of County Communication No. 07-333, from the County Director of Transportation, requesting an opportunity to provide an update on bus stop planning and design, and transmitting a proposal dated July 10, 2007, from KFH Group, Inc., in association with Munekiyo & Hiraga, Inc., entitled "MAUI COUNTY BUS STOP PLANNING AND DESIGN".

### PC-24 TIME SHARE UNITS

**DESCRIPTION:** The Committee is in receipt of County Communication No. 07-267, from the Council Chair, transmitting the following:

1. A draft bill entitled "A BILL FOR AN ORDINANCE TO REGULATE THE NUMBER OF TIME SHARE UNITS". The purpose of the draft bill is to regulate the number of time share units in Maui County.
2. A draft resolution entitled "REFERRING A DRAFT BILL TO REGULATE THE NUMBER OF TIME SHARE UNITS TO THE LANAI, MAUI, AND MOLOKAI PLANNING COMMISSIONS". The purpose of the draft resolution is to refer the draft bill to the planning commissions.
