Count 1. On July 14, 2007 at approximately 10:35 p.m., FLATBREAD PAIA, LLC dba FLATBREAD COMPANY, a dispenser general licensee, did, through its employee, sell, serve, or furnish liquor to a minor, as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, contrary to Section 281-78(b)(1)(A) of the Hawaii Revised Statutes and Section 08-101-60(b)(1)(A) of the Rules of the Liquor Commission, County of Maui.

B. COMPLAINT AND ACCUSATION NO. 2008-21, PLEA: NO CONTEST

In the matter of the accusation against SMILEY'S SUPER SERVICE, INC. dba 2 GO TESORO, Retail General License No. 418, 356 Huku Li'i Place, Kihei, Maui, Hawaii.

Count 1. On July 21, 2007 at approximately 6:42 p.m., SMILEY'S SUPER SERVICE, INC. dba 2 GO TESORO, a retail general licensee, did, through its employee, sell or furnish liquor to a minor, as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, contrary to Section 281-78(b)(1)(A) of the Hawaii Revised Statutes and Section 08-101-60(b)(1)(A) of the Rules of the Liquor Commission, County of Maui.

C. COMPLAINT AND ACCUSATION NO. 2008-22, PLEA: NO CONTEST

In the matter of the accusation against SEAN MCDANIEL dba HANG LOOSE LOUNGE, Dispenser General License No. 172, 333 Dairy Road, Suite #105, Kahului, Maui, Hawaii.

Count 1. On July 14, 2007 at approximately 11:15 p.m., SEAN MCDANIEL dba HANG LOOSE LOUNGE, a dispenser general licensee, did, through its employee, sell, serve, or furnish liquor to a minor, as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, contrary to Section 281-78(b)(1)(A) of the Hawaii Revised Statutes and Section 08-101-60(b)(1)(A) of the Rules of the Liquor Commission, County of Maui.

D. COMPLAINT AND ACCUSATION NO. 2008-24, PLEA: NO CONTEST

In the matter of the accusation against SAIGON PALACE, INC. dba SAIGON PALACE, Dispenser General License No. 346, 310 Hookahi Street, Space Nos. 106 & 107, Wailuku, Maui, Hawaii.

Count 1. On July 22, 2007 at approximately 12:49 a.m., SAIGON PALACE, INC. dba SAIGON PALACE, a dispenser general licensee, did, through their employee, sell, serve, or furnish liquor to a minor, as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, contrary to Section 281-78(b)(1)(A) of the Hawaii Revised Statutes and Section 08-101-60(b)(1)(A) of the Rules of the Liquor Commission, County of Maui.

E. COMPLAINT AND ACCUSATION NO. 2008-25, PLEA: NO CONTEST

In the matter of the accusation against MINIT STOP LOWER MAIN, LLC dba MINIT STOP, Retail Beer and Wine License No. 290, 745 East Lower Main Street, Wailuku, Maui, Hawaii.

Count 1. On June 23, 2007 at approximately 10:16 p.m., MINIT STOP LOWER MAIN, LLC dba MINIT STOP, a retail beer and wine licensee, did, through its employee, sell or furnish liquor to a minor, as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, contrary to Section 281-78(b)(1)(A) of the Hawaii Revised Statutes and Section 08-101-60(b)(1)(A) of the Rules of the Liquor Commission, County of Maui.
