I. HEARINGS BEFORE THE BOARD:

A. COMPLAINT AND ACCUSATION NO. 2008-07, PLEA: GUILTY

In the matter of the accusation against MARGARET, INC. dba NACHOS GRANDE, Dispenser General License No. 330, 3350 Lower Honoapiilani Road, 502 & 503, Honokowai, Maui, Hawaii.

Count 1. On July 5, 2007 at approximately 10:26 p.m., MARGARET, INC. dba NACHOS GRANDE, a dispenser general licensee, did, through its employee, sell, serve, or furnish liquor to a minor, as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, contrary to Section 281-78(b)(1)(A) of the Hawaii Revised Statutes and Section 08-101-60(b)(1)(A) of the Rules of the Liquor Commission, County of Maui.

B. COMPLAINT AND ACCUSATION NO. 2008-02, PLEA: NO CONTEST

In the matter of the accusation against ALE HALE, LLC dba KAHULUI ALE HOUSE, Restaurant General License No. 092 (TEM-08), 355 East Kamehameha Avenue, Kahului, Maui, Hawaii.

Count 1. On December 21, 2006 and December 22, 2006 between the approximate times of 10:30 p.m. and 1:50 a.m., ALE HALE, LLC dba KAHULUI ALE HOUSE, a restaurant general licensee, did, through its employee(s), sell, serve, or furnish liquor to, or allow the consumption of liquor by Cory K. Baisa, who was a minor as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, contrary to Section 281-78(b)(1)(A) of the Hawaii Revised Statutes and Section 08-101-60(b)(1)(A) of the Rules of the Liquor Commission, County of Maui.
