I. HEARINGS BEFORE THE BOARD:

A. COMPLAINT AND ACCUSATION NO. 2007-07, PLEA: NO CONTEST

In the matter of the accusation against MERRILL MAUI VENTURES, LLC dba CIRCLE K EXPRESS / CARL'S JR., Retail General License No. 372, 15 Kapoli Street, Maalaea, Maui, Hawaii.

Count 1. On June 6, 2006 at approximately 7:06 p.m., MERRILL MAUI VENTURES, LLC dba CIRCLE K EXPRESS / CARL'S JR., a retail general licensee, did, through its employee, sell or furnish liquor to a minor, as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, contrary to Section 281-78(b)(1)(A) of the Hawaii Revised Statutes and Section 08-101-60(b)(1)(A) of the Rules of the Liquor Commission, County of Maui.

B. COMPLAINT AND ACCUSATION NO. 2007-16, PLEA: NO CONTEST

In the matter of the accusation against MABC'S CHERRY, LLC dba MULLIGAN'S AT THE WHARF, Dispenser General License No. 169, 658 Front Street, #145C, Lahaina, Maui, Hawaii.

Count 1. On July 14, 2006 between the approximate times of 7:00 p.m. and 9:30 p.m., MABC'S CHERRY, LLC dba MULLIGAN'S AT THE WHARF, a dispenser general licensee, did, through its employee(s), sell, serve, or furnish liquor to, or allow the consumption of liquor by Anita M. Weber, who was at the time under the influence of liquor, as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, contrary to Section 281-78(b)(1)(B) of the Hawaii Revised Statutes and Section 08-101-60(b)(1)(B) of the Rules of the Liquor Commission, County of Maui.

Count 3. On July 14, 2006 between the approximate times of 7:00 p.m. and 9:30 p.m., MABC'S CHERRY, LLC dba MULLIGAN'S AT THE WHARF, a dispenser general licensee, did, through its

employee(s), knowingly permit Anita M. Weber, who was at the time under the influence of liquor, as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, to be or remain in or on the licensed premises, contrary to Section 281-78(b)(5) of the Hawaii Revised Statutes and Section 08-101-60(b)(5) of the Rules of the Liquor Commission, County of Maui.

C. COMPLAINT AND ACCUSATION NO. 2007-17, PLEA: NO CONTEST

In the matter of the accusation against CHARLEY'S RESTAURANT, INC. dba CHARLEY'S RESTAURANT, Dispenser General License No. 198, 142 Hana Highway, Paia, Maui, Hawaii.

Count 1. On July 14, 2006 and July 15, 2006 between the approximate times of 10:30 p.m. and 1:00 a.m., CHARLEY'S RESTAURANT, INC. dba CHARLEY'S RESTAURANT, a dispenser general licensee, did, through its employee(s), sell, serve, or furnish liquor to, or allow the consumption of liquor by Lia Thorpe, who was a minor as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, contrary to Section 281-78(b)(1)(A) of the Hawaii Revised Statutes and Section 08-101-60(b)(1)(A) of the Rules of the Liquor Commission, County of Maui.

Count 3. On July 14, 2006 and July 15, 2006 between the approximate times of 10:30 p.m. and 1:00 a.m., CHARLEY'S RESTAURANT, INC. dba CHARLEY'S RESTAURANT, a dispenser general licensee, did, through its employee(s), permit Lia Thorpe, who was a minor as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, to remain in or about any portion of the licensed premises used or set aside for the sale or consumption of liquor, contrary to Section 08-101-61(h) of the Rules of the Liquor Commission, County of Maui.
