Count 1. On June 9, 2006 at approximately 8:25 p.m., KAHULUI SERVICE, INC. dba LLOYD'S KAHULUI CHEVRON, a retail general licensee, did, through its employee, sell or furnish liquor to a minor, as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, contrary to Section 281-78(b)(1)(A) of the Hawaii Revised Statutes and Section 08-101-60(b)(1)(A) of the Rules of the Liquor Commission, County of Maui.

B. COMPLAINT AND ACCUSATION NO. 2007-15, PLEA: NO CONTEST

In the matter of the accusation against FOODLAND SUPER MARKET, LIMITED dba FOODLAND, Retail General License No. 037, 90 Kane Street, Kahului, Maui, Hawaii.

Count 1. On March 3, 2006 at approximately 1:40 p.m., FOODLAND SUPER MARKET, LIMITED dba FOODLAND, a retail general licensee, did, through its employee, sell or furnish liquor to Francisco Cortez, who was at the time under the influence of liquor, as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, contrary to Section 281-78(b)(1)(B) of the Hawaii Revised Statutes and Section 08-101-60(b)(1)(B) of the Rules of the Liquor Commission, County of Maui.
