WATER USE AND DEVELOPMENT PLAN

DESCRIPTION: The Committee is in receipt of County Communication No. 05-38, from Councilmember Michelle Anderson, relating to the Water Use and Development Plan required by Chapter 2.88A, Maui County Code, and Chapter 174C, Hawaii Revised Statutes (State Water Code).

WATER SUPPLY RULES

DESCRIPTION: The Committee is in receipt of the following:

1. County Communication No. 05-46, from Councilmember Michelle Anderson, relating to Water Supply Rules.
2. Correspondence dated October 11, 2006, from the Department of the Corporation Counsel, transmitting a draft bill entitled "A BILL FOR AN ORDINANCE AMENDING TITLE 14, MAUI

COUNTY CODE, RELATING TO PUBLIC SERVICES". The purpose of the draft bill is to codify rules and regulations of the Department of Water Supply.

3. Correspondence dated June 29, 2007 from Council Chair G. Riki Hokama, transmitting a draft bill entitled "A BILL FOR AN ORDINANCE RELATED TO DROUGHT DECLARATIONS". The purpose of the draft bill is to codify Department of Water Supply drought regulations.

STATUS:

The Committee shall continue its review of the rules of the Board of Water Supply and Department of Water Supply, and recommendations received from the Department of Public Works, Developmental Services Administration, and the Department of Fire and Public Safety. The Committee may also consider regulations regarding drought declarations. The Committee may consider whether to recommend passage of the draft bills on first reading, with or without revisions. The Committee may also consider the filing of County Communication No. 05-46 and other related action.
