**A. COMPLAINT AND ACCUSATION NO. 2006-18, PLEA: NO CONTEST**

**In the matter of the accusation against WEST 1 PROPERTIES, LLC dba PORT TOWN CHEVRON, Retail Beer and Wine License No. 410, 109 Kaahumanu Avenue, Kahului, Maui, Hawaii.**

Count 1. On July 15, 2005 at approximately 7:45 p.m., WEST 1 PROPERTIES, LLC dba PORT TOWN CHEVRON, a retail beer and wine licensee, did, through its employee, sell or furnish liquor to a minor, as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, contrary to Section 281-78(b)(1)(A) of the Hawaii Revised Statutes and Section 08-101-60(b)(1)(A) of the Rules of the Liquor Commission, County of Maui.

**B. COMPLAINT AND ACCUSATION NO. 2006-19, PLEA: NO CONTEST**

**In the matter of the accusation against SIDNEY INOKUMA dba INOKUMA STORE, Retail Beer and Wine License No. 089, 940 Maile Street, Haliimaile, Maui, Hawaii.**

**(CONTINUED FROM MARCH 2, 2006 HEARING)**

Count 1. On July 29, 2005 at approximately 7:13 p.m., SIDNEY INOKUMA dba INOKUMA STORE, a retail beer and wine licensee, did, through its employee, sell or furnish liquor to a minor, as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, contrary to Section 281-78(b)(1)(A) of the Hawaii Revised Statutes and Section 08-101-60(b)(1)(A) of the Rules of the Liquor Commission, County of Maui.

Count 2. On July 29, 2005 at approximately 7:13 p.m., SIDNEY INOKUMA dba INOKUMA STORE, a retail beer and wine licensee, did,

through its employee, fail to check or properly check the identification of a minor, as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, who was in possession of or seeking to purchase liquor at its premises where liquor is sold for consumption off the premises, contrary to Section 08-101-61(b) of the Rules of the Liquor Commission, County of Maui.

**C. COMPLAINT AND ACCUSATION NO. 2006-31, PLEA: NO CONTEST**

**In the matter of the accusation against FOOD PANTRY, LTD. dba LAMONTS, Retail General License No. 285, 200 Nohea Kai Drive, #102, Kaanapali, Maui, Hawaii.**

Count 1. On August 5, 2005 at approximately 8:20 p.m., FOOD PANTRY, LTD. dba LAMONTS, a retail general licensee, did, through its employee, sell or furnish liquor to a minor, as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, contrary to Section 281-78(b)(1)(A) of the Hawaii Revised Statutes and Section 08-101-60(b)(1)(A) of the Rules of the Liquor Commission, County of Maui.

**D. COMPLAINT AND ACCUSATION NO. 2006-32, PLEA: NO CONTEST**

**In the matter of the accusation against MAUI BEACH HOTEL, INC. dba MAUI BEACH HOTEL, Hotel License No. 246, 170 Kaahumanu Avenue, Kahului, Maui, Hawaii.**

Count 1. On July 16, 2005 at approximately 6:07 p.m., MAUI BEACH HOTEL, INC. dba MAUI BEACH HOTEL, a hotel licensee, did, through its employee(s), sell, serve, or furnish liquor to a minor, as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, contrary to Section 281-78(b)(1)(A) of the Hawaii Revised Statutes and Section 08-101-60(b)(1)(A) of the Rules of the Liquor Commission, County of Maui.
