RECREATIONAL AREA REGULATIONS GOVERNING CAMPING

DESCRIPTION:

Correspondence dated July 24, 2007, from the Director of Parks and Recreation, transmitting a revised proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING CHAPTER 13.04, MAUI COUNTY CODE, PERTAINING TO THE RECREATIONAL AREA REGULATIONS". PWF-6 ACCEPTING DEDICATION OF A ROAD WIDENING LOT FOR THE STICE SUBDIVISION (MAKAWAO)

DESCRIPTION: The Committee is in receipt of County Communication No. 07-209, from the Director of Public Works and Environmental Management, transmitting a proposed resolution entitled “ACCEPTING DEDICATION OF ROAD WIDENING LOTS FOR THE BKJK SUBDIVISION, PURSUANT TO SECTION 3.44.015, MAUI COUNTY CODE”. The purpose of the proposed resolution is to accept the dedication of road widening Lots 2-D, 2-E, and 2-F, in Makawao, Maui, adjacent to Ehu and Waiahiwi Roads, consisting of approximately 266 square feet, 367 square feet, and 686 square feet, respectively, TMK: (2) 2-4-13:portion of 218.
