Your Public Works and Facilities Committee, having met on January 31, 2007, makes reference to County Communication No. 07-14, from the Director of Parks and Recreation, transmitting a proposed resolution entitled "AUTHORIZING ACCEPTANCE OF DONATION FROM MAUI ECONOMIC OPPORTUNITY, INC., TO THE DEPARTMENT OF PARKS AND RECREATION, COUNTY OF MAUI, PURSUANT TO SECTION 13-8, CHARTER OF THE COUNTY OF MAUI (2003), AND CHAPTER 3.56, MAUI COUNTY CODE".

The purpose of the proposed resolution is to accept a donation of a 1994 Ford 21-passenger mini bus from Maui Economic Opportunity, Inc. to the Department of Parks and Recreation for County youth recreation programs.

By correspondence dated January 23, 2007, the Co-Chairs of your Committee requested that the Department of the Corporation Counsel incorporate certain nonsubstantive and technical revisions to the proposed resolution for consistency and clarity.

By correspondence dated January 24, 2007, the Department of the Corporation Counsel transmitted a revised proposed resolution entitled "AUTHORIZING ACCEPTANCE OF DONATION FROM MAUI ECONOMIC OPPORTUNITY, INC., TO THE DEPARTMENT OF PARKS AND RECREATION, COUNTY OF MAUI, PURSUANT TO SECTION 13-8, REVISED CHARTER OF THE COUNTY OF MAUI (1983), AS AMENDED, AND CHAPTER 3.56, MAUI COUNTY CODE". The revised proposed resolution incorporates your Committee's suggested revisions.

At its meeting, your Committee met with the Director of Parks and Recreation and two Deputy Corporation Counsel.

There was no public testimony.

The Director stated that the mini bus would be used to transport youth to a variety of youth programs, and had been selected for this donation due to its relatively low mileage and good mechanical condition.

Your Committee discussed the future usage of the mini bus, and recommended that high priority consideration be given to using the bus in the communities of Hana, Molokai, and Lanai that could most benefit from this donation.

Your Committee voted to recommend adoption of the revised proposed resolution and filing of the communication.
