Chair and Members:

Your Public Works and Facilities Committee, having met on March 14, 2007, makes reference to County Communication No. 07-79, from the Director of Public Works and Environmental Management, transmitting a proposed resolution entitled "ACCEPTING DEDICATION OF A ROAD WIDENING LOT FOR THE LAND COURT APPLICATION 862 SUBDIVISION, PURSUANT TO SECTION 3.44.015, MAUI COUNTY CODE".

The purpose of the proposed resolution is to accept the dedication of road widening Lot 430-E-1-A-2-C in Kaunakakai, Molokai, along Kolapa Place, consisting of 0.041 acre and identified as TMK: (2) 5-3-02:169, in order to complete the Kolapa Street Sidewalk Improvements (County of Maui Job No. 06-32).

Your Committee notes that, pursuant to Section 3.44.015(C), Maui County Code, the Council may accept gifts or donations of real property or any interest in real property by the passage of a resolution, approved by a majority of its members.

At its meeting, your Committee met with the Director of Public Works and Environmental Management and a Deputy Corporation Counsel.

There was no public testimony.

The Director stated that the developer was required to dedicate the road widening lot upon receiving final subdivision approval on June 8, 1977, but that the dedication never occurred. He stated that the road widening lot is two feet in width and extends along Kolapa Place. He further stated that the pending Kolapa Street Sidewalk Project will require that the road widening lot be dedicated prior to construction.

Your Committee voted to recommend adoption of the proposed resolution and filing of the communication.
