Chair and Members:

Your Public Works and Facilities Committee, having met on September 5, 2007, makes reference to County Communication No. 07-205, from the Director of Public Works and Environmental Management, transmitting a proposed resolution, entitled "ACCEPTING DEDICATION OF A ROAD WIDENING LOT FOR THE PARTITION OF HUI KUAI AINA O PEAHI SUBDIVISION, PURSUANT TO SECTION 3.44.015, MAUI COUNTY CODE".

The purpose of the proposed resolution is to accept the dedication of road widening Lot 158-D in Haiku, Maui, along Kaupakalua Road, consisting of approximately 0.08 acre, and identified as TMK: (2) 2-8-06:portion of 044, for public purposes.

Your Committee notes that, pursuant to Section 3.44.015(C), Maui County Code, the Council may accept gifts or donations of real property or any interest in real property by the passage of a resolution, approved by a majority of its members.

By correspondence dated August 9, 2007, the Co-Chairs of your Committee requested that the Department of the Corporation Counsel incorporate technical revisions to the proposed resolution.

By correspondence dated August 10, 2007, the Department of the Corporation Counsel transmitted a revised proposed resolution, as requested by the Co-Chairs of your Committee.

At its meeting, your Committee met with the Director of Public Works and two Deputy Corporation Counsel.

There was no public testimony.

The Director provided a brief overview of the subject road widening lot and responded to your Committee's questions about the subject subdivision.
