SETTLEMENT AUTHORIZATION OF CLAIMS AND LAWSUITS (DANIEL K. KANAHELE, ET AL. V. MAUI COUNTY COUNCIL, ET AL., CIVIL NO. 08-1-0115(3))

DESCRIPTION:

The Committee is in receipt of correspondence dated May 16, 2008, from the Department of the Corporation Counsel, requesting consideration of a proposed resolution entitled "AUTHORIZING SETTLEMENT OF DANIEL K. KANAHELE, ET AL. VS. MAUI COUNTY COUNCIL, ET AL.; CIVIL NO. 08-1-0115(3), SECOND CIRCUIT COURT, STATE OF HAWAII" and transmitting a copy of the complaint. The complaint alleges the Maui County Council violated the State's Sunshine Law, Chapter 92, Part I, Hawaii Revised Statutes. The purpose of the proposed resolution is to authorize settlement of the case.

STATUS:

The Committee may consider whether to recommend adoption of the proposed resolution, with or without revisions. The Committee may also consider other related action.
